

## **Registration Terms and Conditions**

Terms and Conditions (updated September 2021)

Youth Goalkeeping Membership (membership for coaching only)

These terms and conditions apply to all players registered with the company whose details are submitted using an online registration and/or who take part in any footballing activity for the company. By signing this registration form or allowing your child to take part in activities organised by the company you agree that you and your child will comply with these terms and conditions.

- 1. You agree to pay fees due to the company subject to such fees having been previously notified to you by the company. You acknowledge that your child attending activities run by the company after fees have been notified to you shall be acceptance of your liability to pay such fees. Should these fees change, the company shall inform you at least two weeks before the start of the next block of sessions. The sessions are 1-hour and are delivery of **goalkeeper-specific coaching** and development.
- 2. You acknowledge that you have taken the time to read the Privacy and Safeguarding policies put in place by the company. SAFEGUARDING POLICY. It is assumed by the company that by registering or allowing your child to take part in activities organised by the company that you have read these.
- 3. You understand that if you are unable to attend a session that is delivered, you will forfeit that week. If you have a planned absence when making your 10-week block booking or your son/daughter is going to be absent for a prolonged period (e.g., injury) please inform Carl Green as soon as possible. If fde. must postpone a session (severe weather etc.) you will be notified by email and/or phone and that session will be rescheduled.
- 4. You consent to the company taking photographs and/or videography of your child and for such recordings to be used by the company for promotional purposes (including on the website or social media).
- 5. We may send you emails (including marketing) from the company at the email address supplied during registration.
- 6. Studded boots are not permitted at Bishops Stortford. For every session players are required to attend with enough drink to keep them hydrated for one-hour of coaching.
